Frequently Asked Questions (1 year Apprenticeship Training)

1. How do I register for the online application process?

Online registration for 1 year apprenticeship training in BCPL is a two-step process.

Step-1: In the first step, you have to register yourself at the National Apprenticeship Training Scheme Portal (NATS Portal). After successful registration, you will get an Enrolment Number/Registration Number from NATS portal. This Enrolment Number/Registration Number will act as a pre-requisite for Step-2 registration.

Step-2: In the second step, you will fill up an application form online, where you will mention the Enrolment Number/Registration Number obtained from NATS portal along with personal details, educational qualification details and some other relevant information. You also need to upload one colour passport size photograph and signature in JPG/JPEG format. After successful submission of application, a registration slip will be generated which you can keep it with you for future reference.

2. What if I do not have an e-mail ID and a valid mobile phone number?

It is mandatory to have a valid e-mail id and a valid mobile phone number since all the future communication with the candidate shall be through e-mail/SMS/website. BCPL would communicate by any of the above 3 modes. Also note that your email ID and mobile number should be operational and valid for the next 1 year from the last date of application submission.

3. How do I know that I am eligible for this apprenticeship training program?

Please read the “Detailed Advertisement” available on BCPL website to read about the eligibility criteria.

4. Is there any application fee for the apprenticeship training program?

No. There is no application fee for the 1 year apprenticeship training program in BCPL.

5. Can I save my application while applying?

Yes, you can save the application at any point of time while filling the same. It can be done by clicking on “Save” button provided at the end of the page. Once the data is saved, the system will give an alert – “Data Saved”.

6. What do I receive after successful submission of the application form?

After successful submission of application, a unique application number will be generated along with the registration slip, containing all the details of filled in application form. Candidate will also receive a confirmation mail of the registration.

7. What would be the use of this registration slip?

Registration slip will contain all the information filled in by candidate. It can be used for future reference.

8. What are the documents that I need to send along with the hard copy of my application?

You are not required to send any documents to BCPL after submitting the application online.

9. Can I make any changes to the form after submission?

No, you cannot make any changes to the form after you submit the same.

10. How would I be contacted by BCPL?

All communication shall be through the e-mail id provided by you and information shall be hosted on BCPL's web site.

11. My current residential address is temporary and it is likely to be shifted soon, so which address, I should provide?

Candidate should provide correct correspondence address with Pin Code which remains valid for at least one year, and it may be used by BCPL for future communications.

13. Is there any employment after successful completion of Apprentices Training?

Yes, you are eligible to apply, if you do not have any past experience.
